2. All first-year undergraduate students are assured a cozy accommodation experience right on campus, where the vibrant atmosphere fosters community and learning. The safety and security of residents are paramount, ensured by dedicated Block Supervisors, an attentive Warden, a vigilant Chief Warden, and a trained Security Staff, all working alongside the Head of Campus Safety to create a nurturing and secure environment within the hostels.
3. **Important Note:** While all students are strongly encouraged to immerse themselves in the lively life of university hostels, it is **MANDATORY** for first-year undergraduate students to reside on campus. However, for those first-year students who prefer to explore living arrangements outside the university, a consent letter from their parents is required, accompanied by a recommendation from their Head of Institution (HOI). This letter must be submitted to the Director of Student Affairs, who will grant the necessary permission for off-campus living.
4. In addition to this process, students must provide their local address and contact/mobile number. It is essential for them to promptly inform both their College Office and the Director of Student Affairs of any changes to their contact details to maintain effective communication.
5. For postgraduate (PG) students, accommodation options are somewhat limited and allocated based on the availability of vacancies, adhering to a first-come, first-served approach. Consequently, if no vacancies exist in the hostels, students may need to seek alternative accommodations to ensure a comfortable living situation. Special provision is made for students of the WGSMA, as well as those enrolled in the esteemed Department of Culinary Arts and the Department of Allied Health, fostering a supportive and community-oriented living environment tailored to their unique needs.

6. At Manipal, we offer a comfortable and inviting hostel experience for students pursuing Hospitality Studies. Our accommodation options include both air-conditioned and non-air-conditioned rooms available for boys and girls, featuring single and twin-sharing arrangements with private attached bathrooms for added convenience.
7. The air-conditioned rooms are limited in number and will be allocated on a first-come, first-served basis, so early application is encouraged to secure a pleasant living environment. Each room comes furnished with essential items, including a cozy bed with a comfortable mattress,

a spacious study table, a chair, and a cupboard, ensuring a conducive atmosphere for studying and relaxation.

8. Our hostels are equipped with a range of modern amenities to enhance student life. Enjoy uninterrupted power supply, a common TV room for social gatherings, and treated and chilled drinking water to keep you refreshed. Engage in recreational activities through our indoor games facility, take a moment to unwind in the reading room, or stay connected with our high-speed Wi-Fi and internet cafe.
9. For those who enjoy outdoor activities, our hostel complex features volleyball and basketball courts, providing ample opportunity for exercise and friendly competition. Experience a well-rounded lifestyle at Manipal, where comfort and convenience come together to create a vibrant student community. Experience comfortable living with our hostel accommodation options, which cater to both air-conditioned and non-air-conditioned preferences. Available on a single or twin-sharing basis, each room boasts an attached bathroom, ensuring privacy and convenience for all residents. Please note that the number of air-conditioned rooms in both boys' and girls' hostel blocks is limited, and accommodations will be allocated on a first-come, first-served basis.
10. For those seeking leisure, we offer indoor games, a serene reading room, and exciting outdoor activities. Stay connected with Wi-Fi and our internet café, while laundry needs are met with available washing machines. Get active in our volleyball and basketball courts, perfect for both recreation and competition. Your home away from home awaits.

ALLOTMENT OF ROOMS

1. All students are required to bring three passport-sized photographs, which will be essential for their hostel admission during the counselling session. These photographs play a crucial role in the identification process and ensure a smooth entry into the hostel system.
2. Students can conveniently pay the hostel facilities fee, deposit, and mess advance either at the time of counselling or during the registration/admission process. This flexibility allows students to manage their expenses effectively as they transition into campus life.
3. Every effort will be made to accommodate all students in the hostel, depending on the availability of rooms. The administration is committed to ensuring that students have a place to live that fosters an academic environment.
4. It is **MANDATORY** for all first-year undergraduate (UG) students to reside in the hostels and participate in the campus mess. This policy aims to promote community living and engagement among newcomers. In exceptional cases, the Dean or Director may grant permission to stay off-campus prior to joining the hostel; however, it is important to note that if a first-year student vacates the hostel, their hostel facilities fee paid for the year will be forfeited, underscoring the importance of this requirement.

5. Students must occupy only the rooms that have been specifically allotted to them. Changing rooms is strictly prohibited unless students receive written permission from the Warden or Chief Warden. Additionally, transferring from one hostel to another during a term is generally not permitted, ensuring stability and consistency in living arrangements.
6. The allotment of rooms is subject to cancellation if a student fails to occupy the assigned room within the designated time. Furthermore, students will forfeit their allocated rooms if they do not clear all outstanding dues to the hostel by the specified deadline. In such circumstances, they may be asked to vacate the premises, emphasizing the importance of timely financial responsibility.
7. Hostel accommodation is granted solely at the discretion of the Chief Warden, with the understanding that students agree to abide by the extensive rules and regulations governing hostel life. The Chief Warden reserves the right to deny hostel facilities without providing any justification or to remove a student from the hostel at any time due to disciplinary infractions, ensuring a respectful and orderly living environment.
8. The Chief Warden is empowered to break open rooms if there are breaches of hostel rules, suspected unlawful activities, or any perceived security risks, thereby prioritizing the safety and well-being of all residents.
9. Once a student vacates the hostel, they will not be eligible for reallocation of hostel accommodation for a minimum period of six months. This policy serves to promote commitment to hostel life and to limit disruptions within the community.
10. The first-year undergraduate students of WGSMA, from the Department of Culinary Arts and the Department of Allied Hospitality Studies, can take accommodation both AC and NON-AC rooms by selecting and making payment online through hms.manipal.edu portal.
11. Marena - Manipal Indoor Sports Arena is located next to the hostel blocks, and students are encouraged to become members for various sports activities.

HOSTEL FACILITIES FEE AND DEPOSIT

1. **Hostel Facilities Fee:** The hostel facilities fee is an essential annual expense for all first-year students, ensuring they have a comfortable and fully-equipped living environment. This fee is mandatory for all students, with the exception of local residents and postgraduate students, who are encouraged to stay in the hostel during their initial year. Fees vary based on the specific type of accommodation chosen, reflecting the diverse living options available. Payments for the hostel facilities fee will be collected at the start of each academic year, following a schedule communicated by the University or the dedicated hostel accounting office. To encourage timely financial responsibility, a late payment will incur an additional fine of 12% per annum for each day it is overdue. Any outstanding hostel fees will be promptly

communicated to students or their parents via email, serving as a gentle reminder. We highly encourage students and parents to prioritize timely payments to avoid unnecessary fines. For detailed inquiries regarding the payment schedule and comprehensive fee structure, students are welcome to reach out to the MAHE Finance Department for assistance. Additionally, students residing in air-conditioned rooms are required to pay an "AC Electricity Advance," which is separate from the "Hostel Deposit" and "Hostel Facilities Fee." This advance serves as a monthly credit against the electricity bill incurred from air conditioning usage, based on actual consumption. Once this advance is depleted, students will be responsible for covering any additional electricity costs for the remainder of their stay.

2. Every student admitted to the hostel is required to make a Hostel Deposit. The deposit will be refunded when the student vacates the hostel on production of a 'Dues Clearance Certificate'. The amount of hostel deposit is published along with the schedule of hostel facilities fee.
3. **Hostel Facilities Fee for Casual Students:** Students who do not complete their studies within the regular period stipulated for the course have to vacate their hostel rooms. However they may be allotted alternate accommodation as per availability for a further term(s) on non-priority basis subject to the following: 50% of the annual hostel facilities fee will be charged to such students for a term not exceeding six months. The student will have to pay the hostel fee for the entire year for retaining accommodation beyond a period of six months.
4. **Payment of Hostel Facilities Fee & Deposit:** The hostel facilities fee/deposit may be remitted through Online and can be paid at the time of counselling or registration/admission:

HOSTEL DISCIPLINE

1. **Room Curfew:** All students are required to remain in their assigned rooms during the night to foster a secure and peaceful environment. If any student wishes to be away from their room after designated nighttime hours, they must obtain prior written permission from the Warden without exception. This includes first-year undergraduate students who may wish to leave the campus for any reason, whether it be for a brief errand or an extended outing. To do this, they must secure written consent from multiple authorities, including their Dean, Teacher Guardian, Warden, and the Chief Warden. It is essential that students provide detailed information regarding their planned departure, including the specific date, the exact times they intend to leave and return, as well as their intended destination. This vital information should be meticulously recorded in the In-Out Register kept in every hostel, ensuring a clear and orderly tracking of students' whereabouts for safety and accountability.

2. **Pets and Stray Animals:** In our commitment to maintaining a clean and orderly living environment, the possession of pets of any kind within the hostel premises is strictly forbidden. This policy helps prevent potential disturbances and health risks associated with animals in shared living spaces. Additionally, feeding stray dogs or cats within the hostel grounds is not permitted, as it can attract unwanted wildlife and jeopardize the hygiene of our community space.
3. **Ragging Policy:** To cultivate an atmosphere of respect, dignity, and mutual support, ragging in any form—be it verbal harassment or physical bullying—is unequivocally banned on campus and its immediate surroundings. This zero-tolerance policy is in place to ensure that all students can feel safe and welcomed within the academic community. Any reported violations will be met with serious disciplinary actions, reinforcing the importance of kindness and support among peers.
4. **Valuables and Cash:** Students are strongly encouraged to avoid keeping large sums of cash or valuable possessions, including jewelry, electronics, or important documents, in their hostel rooms. Each student is wholly responsible for the safety and security of their belongings, and we recommend utilizing bank services or secure storage facilities provided by the institution for safeguarding valuable items. This communal responsibility fosters a secure living environment for everyone.
5. **Visitor Policy:** To promote an atmosphere of respect and privacy, all visitors—including parents, guardians, and friends—are required to meet with students exclusively in the designated Visitors Lounge during specified visiting hours. This ensures a structured and monitored environment for interactions. Students must also arrange for a Visitor's Pass well in advance through the Chief Warden's office, allowing for a smooth entrance while upholding the security of the hostel community.
6. **Cooking Restrictions:** In the interest of health and safety, cooking within the confines of hostel rooms is strictly prohibited. This regulation is enforced to prevent fire hazards, maintain cleanliness, and ensure the overall comfort of all residents. Students are encouraged to take advantage of the well-equipped cafeteria or dining facilities, which offer a diverse array of nutritious and delicious meals, promoting a communal dining experience.
7. **Quiet Hours:** To ensure a conducive environment for studying and rest, designated quiet hours will be established during which students are expected to maintain low noise levels. This period will typically last from 10 PM to 7 AM on weekdays. Activities that generate loud noise, including gatherings or music, should be avoided during these hours to respect fellow residents' need for peace and tranquility.

8. **Room Inspections:** Regular room inspections will be conducted by the hostel management to ensure compliance with hygiene and safety standards. These inspections aim to maintain a clean environment and monitor adherence to the rules. Students are expected to keep their rooms tidy and be respectful to the inspecting staff during these visits.
9. **Substance Abuse Policy:** The use, possession, or distribution of illegal substances, including drugs and alcohol, is strictly prohibited on hostel premises. The hostel aims to promote a healthy lifestyle, and any violations of this policy will result in severe disciplinary action, including possible expulsion from the hostel.
10. **Emergency Protocol:** Students are required to familiarize themselves with the emergency procedures and protocols of the hostel, including fire drills and evacuation routes. Regular emergency drills will be conducted to ensure that all students are well-prepared for any unforeseen circumstances, emphasizing the importance of safety and preparedness in our living community.
11. **No private vehicles except cycles** are permitted on the hostel premises as all facilities within the campus are within walking distance.

We trust that all students will embrace and adhere to these guidelines, contributing to a harmonious, safe, and respectful living experience for everyone within our hostel community. Your cooperation is greatly appreciated and essential for maintaining a positive environment.

HOSTEL MESS AND CAFETERIA

Manipal Health Sciences Campus

1. In accordance with the policy set forth by MAHE, all first-year undergraduate students residing in the hostel are required to become members of one of the messes operated by MAHE-approved vendors. This membership is aimed at fostering a sense of community and ensuring access to nutritious meals. From the second year onward, students have the liberty of discontinuing their mess membership, offering them greater flexibility as they progress in their studies.
2. The annual mess charges, designed to cover the cost of meals, will be collected alongside the hostel fees and utility charges, making financial planning easier for students and their families. To prioritize the health, safety, and security of all students, it is mandatory for those living in the hostels to dine at one of the designated messes located on campus. These include the bustling Food Court Mess, known for its vibrant atmosphere and diverse menu options, and Spade Integrated Services Pvt. Ltd., recognized for its quality service and wholesome meals.
3. To facilitate this arrangement, students are required to pay an annual mess advance with their hostel fees, ensuring that they can conveniently enjoy their dining experiences while focusing on their academic pursuits.

4. Note: Students are encouraged to explore the various mess facilities available and make their registration or payment accordingly upon their arrival in Manipal. Each month, the actual mess bill will be communicated, reflecting the dining services provided, and will be deducted from the advance payments already collected.
5. It is important to understand that any increase in the actual charges, as compared to the initially collected advance, will become the responsibility of the students. In the event of that, there is any excess amount identified after the actual bill has been calculated, that surplus will either be adjusted against the charges for the following period or refunded to the students.
6. Please be aware that late payments will attract a penalty of 12% per annum, which will be computed for every day of delay. This fine will be enforced starting from the day after the final date designated for the payment of the bills. Students are encouraged to ensure timely payments to avoid any unnecessary fees.
